6 BY MS. JONES:

7 Q. In 57.1.1, you have a beginning and an end date,
8 but you have no contest limit; is that right?

9 MR. CALFO: Object to the form.

10 A. But you have no what?

11 BY MS. JONES:

12 Q. Contest limit.

13 MR. CALFO: Object to the form.

14 A. There's no reference to contest.

15 BY MS. JONES:

16 Q. And is that because there's no contest in the
17 summer activities time period?

18 A. Correct.

19 MR. CALFO: Object to the form.

20 BY MS. JONES:

21 Q. And 57.1.1, in comparison to 57.1.0 on the
22 previous page, the 57.1.0 does have a regular season
23 contest limit. Do you see that?

24 A. Yes.

25 MR. CALFO: Objection, form.

1 BY MS. JONES:

2 Q. And that's because 57.1.0 refers to the
3 competitive season; is that correct?

4 MR. CALFO: Object to the form.
