To Whom It May Concern:

Starting in 2012 my company Trident Solutions LLC DBA as CrossFit Bellevue began adopting a family to help out at Christmas time via the Bellevue Boys and Girls Club. We have helped out a family in need every year since this time.

In December 2013 I asked Chris Burnside (Bellevue Boys and Girls Club) to help me find a Bellevue family in need that may or may not be part of our program. I was informed by him that the Dyles family was in serious need and had requested assistance from the BGC to help with Christmas. I told Chris I wanted to sponsor this family anonymously through my business and ensure they had a fun and fulfilled Christmas. In turn I submitted a donation request to the members of my gym about the fundraiser and they helped donate toys and food for this family and others.

Later that same month I was informed that Ahmad Dyles had lost his job and was in need of a job. I looked at my business finances and made a decision to stop paying my son who attends University of Washington and works at my business as a cleaning person and I extended an invitation to work to Ahmad Dyles. Ahmad accepted this job without prejudice at a rate of \$10.00 dollars per hour and worked for 3-days prior to Christmas. On Christmas Eve knowing Ahmad did not have funds, my company offered to pay Ahmad for his services in advance so he could have funds to provide for his family over the holiday. Our company paychecks were not to be processed until January 4th of 2014. On Christmas Eve, my company paid Ahmad \$240 dollars as an advance because we simply wanted to help him enjoy his Christmas. At that point in time, Ahmad had been paid a total of \$240 by my company and had only worked eight hours.....he owed my company (and still does to this day) 16 hours of work. I am still waiting for Ahmad to be a man of his word and finish his work.

On December 28th after not hearing from Ahmad for the last few days I called Ahmad to inquire if he was returning to work to finish the work I had paid him for. He informed me that he had been hospitalized and was unable to communicate with me. He informed me he would return to work the on December 30 which he did.

On December 30th Ahmad returned to work and worked on the 30th and 31st. He worked a total of five hours. At that point, he still owed our company for 11 hours of work. Also on December 31st, Ahmad asked me for an advance on his wages as he was seriously lacking funds and in desperate need. Reluctantly (very reluctantly), I advanced Ahmad another \$250 dollars for an additional 25 hours of work we expected to be completed. Ahmad never returned to work and stopped answering my phone calls and texts for days. On January 7th Ahmad informed me he had not contacted me because of serious financial issues. He informed me at this time if he did not pay his rent he would be evicted from his apartment and would be homeless.

On January 8th I sent an e-mail to my clients and stake holders asking them to assist me in finding charitable donations to help this family out. (E-mails have been submitted to Lauren McDaniel, Athletic Director Bellevue High). Several high level stake holders replied giving me great advice of which I took action on every suggestion to include Hope-link, Saint Vincent De Paul, Youth Eastside Services,

Jubilee Reach, Salvation Army and many more. I personally called everyone of these organizations and received information for Ahmad to use. Ahmad told me he had exhausted these resources already and would not be contacting them. At this time Ahmad again informed he was going to be evicted shortly if he did not receive rent money.

On or about January 10th, Brian Valentine a personal training client of mine offered to donate the funds in full to Ahmad Dyles. I refused his donation and told him I wanted to exhaust all efforts and held out hope to find a charitable donation. On or about January 11th Ahmad Dyles called me pleading with me to help him with his rent or he would be evicted. I called Brian Valentine and told Brian I would accept responsibility for the funds and that if Ahmad did not pay them back I would be responsible for them.

Brian delivered a check written to Ahmad Dyles directly. At this time I informed Ahmad that this was not a gift and that this was loan. I told Ahmad this loan must be paid back in a timely manner, and Ahmad Dyles gave his word that it would be. Ahmad Dyles did not tell the truth and did not pay back these funds.

In March of 2014 after not hearing from Ahmad for a long period of time, I confronted him about these funds and he said he would get them back to me as fast as possible. This was the last time I spoke to Ahmad until September of 2014 at which point I avoided all conversation with him due to annoyance with the matter. On or about March 15th, I paid Brian Valentine back his loan in full. As of the writing of this email, Ahmad Dyles still owes Crossfit Bellevue for 36 hours of labor (\$360). Additionally, as I personally guaranteed a loan that he received from Brian Valentine, and since Ahmad has neglected to make good on this loan and has defaulted, I had to honor my word and as the guarantor, I had to pay Mr. Valentine with my own funds due to Mr. Dyles default.


When I spoke to the investigator I was irritated and did not give a full and clear explanation for that I deeply apologize. I told her I gave Ahmad these funds but did not give a full and clear explanation. I also told her I did not expect Ahmad to ever pay back these funds. I said this not to mean it was a gift but to mean I now believe that he lacks any sort of integrity or commitment to ever pay these funds back. Ahmad still owes back the funds, and the 36 hours of work and the loan guarantee...this debt has NOT been forgiven. As the saying goes, no good deed goes unpunished. During my conversation with the investigator, I made it very clear regarding the type of person I believed Ahmad Dyles to be. I do not why the investigator did omit this explanation.... her statements there are not particularly representative of our discussion.


