Mr Lowell

It sounds as though we will have to meet again as where we left things at our last meeting are not reflected in your below. Anyhow....

1: Thank you for moving the BCA time back to where it was at 4:30pm. When you notify someone on a Saturday of a time change for the immediate Monday following to something that has been on the books for months, it is rather disconcerting and for all you know, we may have a paid guest speaker coming in at that time or some other time sensitive situation that does not lend itself to a last minute change like that...in fact, I'm shocked that you did not notify all of the coaches through your AD's of what to expect as your below is quite different than what was originally proposed. I guess they'll just find out at the meeting.

2: Your below is confusing and not really addressing what my point was...we understood competitive cheer and the assistant for it would be a position in the first year and paid in the first year of the contract. Mr Lowell, adding more words to the contract is not our goal and it is our experience it creates more problems often rather than less. Anyhow, the point was not how it was stated in the contract, but the fact that it isn't included as part of year 1 as our notes from the meeting show it as being included as part of year one.

3: Mr. Lowell, the handbook is not the CBA contract...it is the coaches handbook that you created that you and your investigator kept referring to over and over again...no one is asking you to provide a copy of the CBA contract...we are simply suggesting that providing your coaches a copy of your coaches handbook would be a really good idea each year at your meeting and well worth the cost of the printing.

4: Mr Lowell, nearly each time you email me, a new version of the contract emerges. Please stop. All of the extra verbage and percentages and all that stuff makes things more confusing rather than explanative. I went through it last week with Mr. Thomas and that is the version I am still on. If there is something you want to propose differently, rather than sticking something new into the contract and sending it out, propose the word change without sticking it into the contract and first see if we all agree. From our end, we are still looking at the hard copy version from last week. The point of issue with number 1 on the notes of the stipend schedule is that spring/summer football is not not part of the 12 week competitive season and it is not "off-season" either...so by this reference, it is not included in the stipend schedule as those two things are included. We will leave the wording there as is, and I will take this issue up through a different avenue.

5: As a sidenote, as you are the district athletic director, what has BSD decided to do regarding locker room security during practices? As we have stated over and over again, it is not a responsibility of the coaches once they leave the locker room...yet with tutorial and extended tutorial there are students coming in at all different times to practices who need to visit the locker room. Following your rules, we would always need more than one coach with that student and we cannot afford one coach let alone two coaches to leave practice so that one student can go to the locker room to get dressed (ie so that we are not one on one with a student athlete). I spoke to the Dr Mills on this subject and he suggested a Vibes person. You tried to make the position part of our contract (which it cannot be because that type of a position is not a coaching position). Anyhow, nothing was done for spring ball and the issue continued, and here we are about to start again...and we need to avoid the Juanita situation and should feel quite fortunate that it hasn't been an issue to date for

BSD...but it is only a matter of time. If you are going to have tutorial and extended tutorial, part of that means you have to have a way for your student athletes to dress safely and appropriately without disrupting or stopping the ongoing practice. Anyhow, there appears to be absolutely zero direction from BSD regarding this...ie no procedure. Please let me know what the plan is for this...and what procedure we should all follow?

Also, we did not agree to "remove" reimbursements as you put it, so that wording will need to be better sorted out. We understand the pooling of the funds, but that would not prevent > reimbursements up until there are some more specifics determined on how this will be done. We collectively left that part a bit vague but it would be premature at this point to state that reimbursements still cannot > happen. I get the gist of it, but we're not there yet. > > > If you looked closer at the stipend schedule for 2015-2016, yes, competitive cheer was listed, but in the far left column, there was an indication that there is no authorized position for 2015-16. However, to > make it more apparent, I have removed Competitive Cheer from the 2015-2016 > stipend schedule. > > > > Also - so as to not have to add two charts with the percentages for head coaches, competitive cheer was listed. Again, in order to make it more clear, there is an additional column now on that chart that states it is а > New Position in Yr. 2. > > > The wording in the summary regarding reimbursements has been 'cleaned up' > as well. There is no reference in the summary to reimbursements:

(Professional Development has been updated as well. Coaches will receive а > membership in the WSCA each year, purchased by the district. The district > will also be budgeting for and offering professional development through the year. Money budgeted is in a pool. Additional information will be forthcoming about these opportunities.) > > > > > > 3: I would recommend handing all coaches a copy of the handbook as they enter the meeting. May seem like a waste of paper Mr Lowell but given what > we've seen happen over the past year particularly at Bellevue and Interlake, I would strongly recommend all coaches get a copy of the handbook as they enter the meeting....and make that an annual process. > > > > Thank you for the suggestion - however, the CBA reads: The District shall > post this Agreement on its website for access by all employees represented > by the BCA who conduct extracurricular activities. A copy will be available at each school.
